Webinar: "Commemorating the 64th Anniversary of 'The Blue Jerboa', the first French Nuclear Test in Algeria "

"Unheard Voices: Shedding Light on Algeria's Nuclear Test Victims"

Context and Importance:

The webinar aims to highlight the oft-overlooked yet significant history and impact of the nuclear tests conducted in Algeria, commemorating the first test known as "The Blue Jerboa." These tests, carried out by France during the 1960s, have left lasting scars on the environment and the health of the Algerian people. Despite their profound impact, these events have not received adequate global attention or recognition. This webinar seeks to rectify this by focusing on the historical, environmental, health, legal, and advocacy aspects related to these tests and a broader look into nuclear weapons and the need for their prohibition globally and an open call to the global ratification of the TPNW.

- Historical Context: Understanding the geopolitical background and motives behind "The Blue Jerboa" tests.
- Environmental and Health Impacts: Assessing the ecological damage and health consequences for the local populations.
- Legal Perspectives: Examining international law and human rights frameworks relevant to nuclear testing and victim compensation.
- Advocacy Strategies: Discussing the role of NGOs and international bodies in raising awareness and supporting victims.
